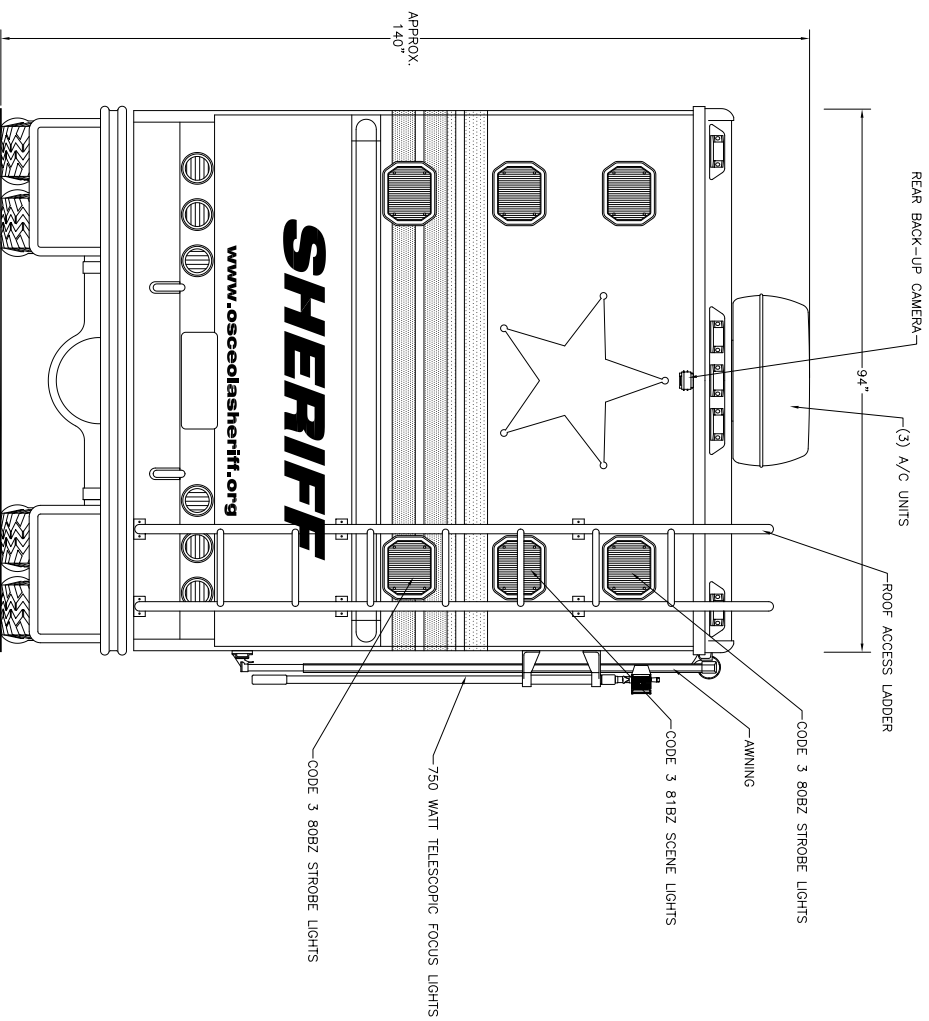


*Front View*

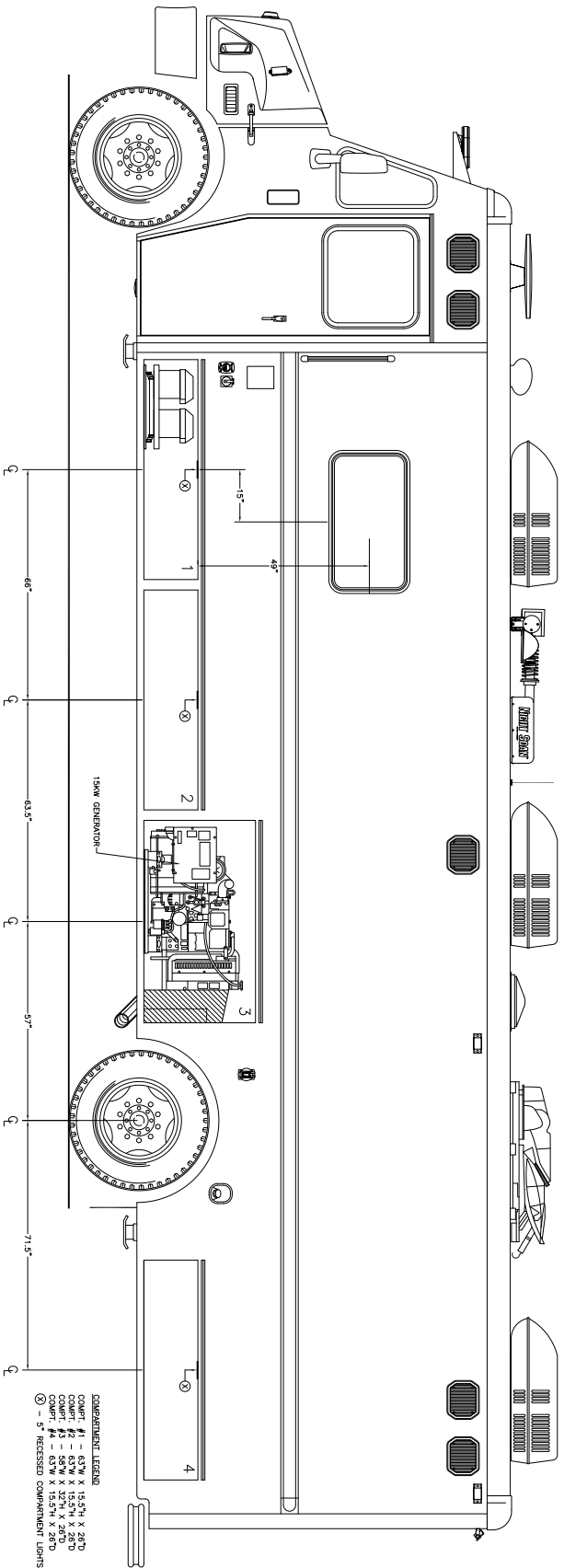


*Rear View*

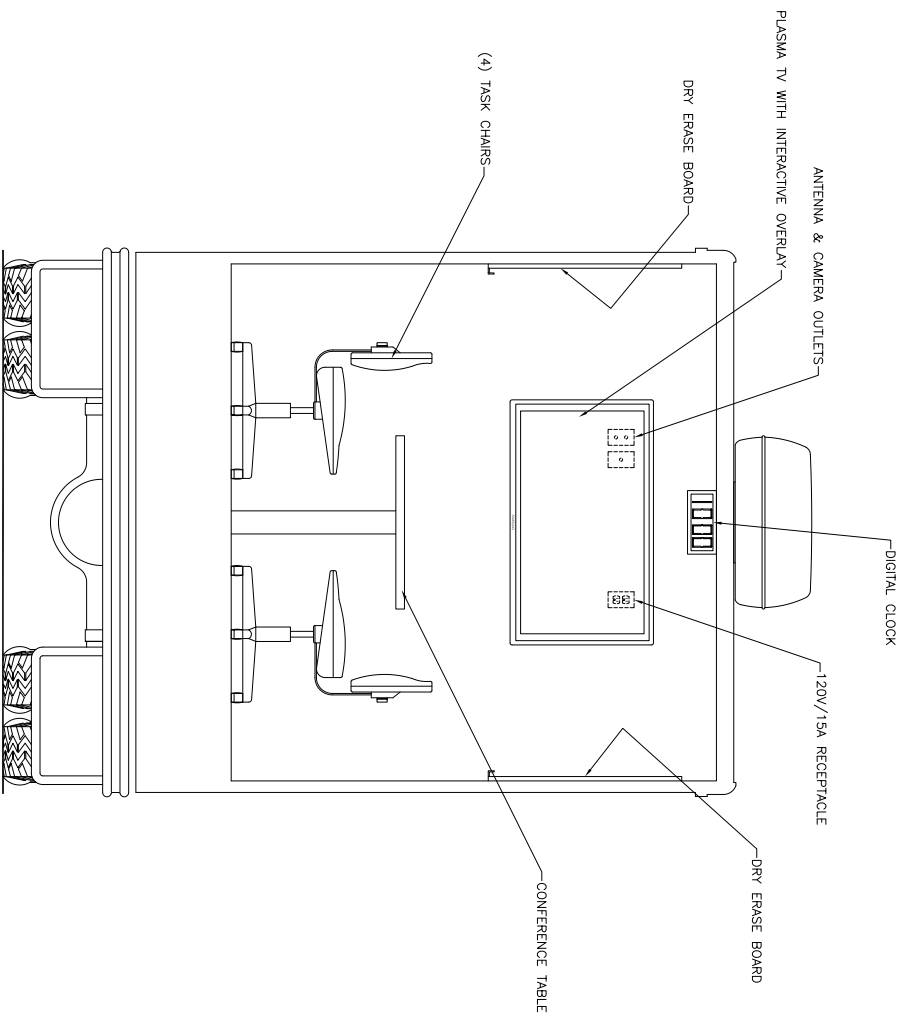


*Front Interior*

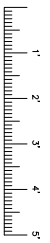
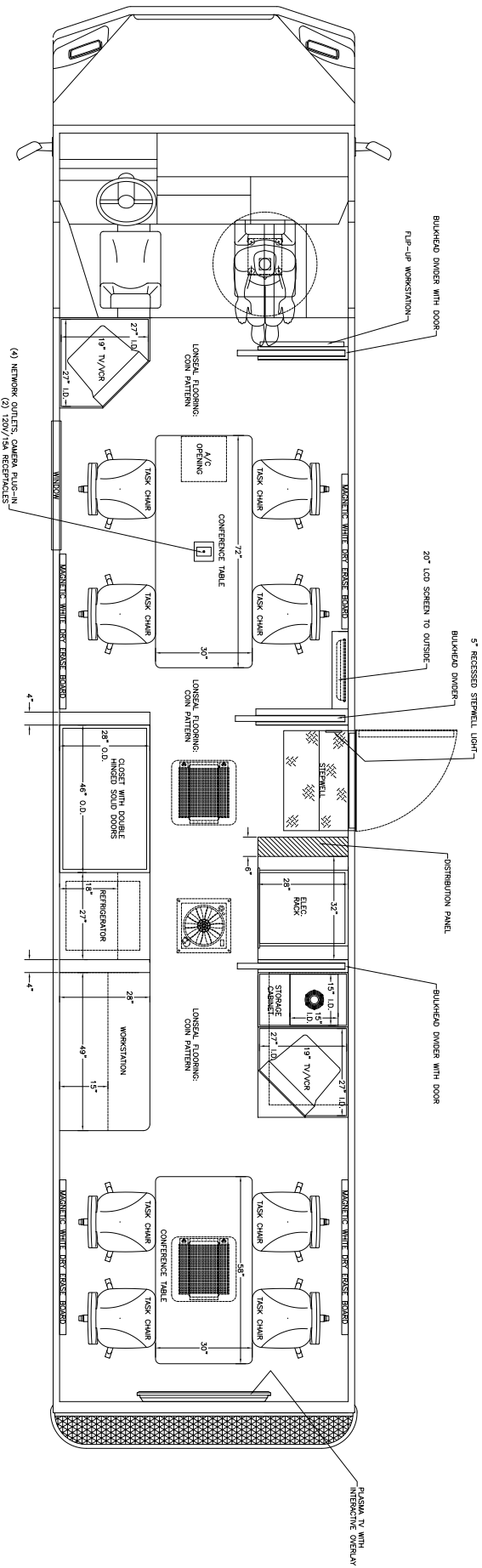


*Rear Interior*
